## Life Teen Summer Staff Application Process

- Step 1:** Type your resume.  
**Step 2:** Complete Application and background check.  
**Step 3:** Direct, produce, and record a video that shows what you are all about. Show your school, your friends, your ministry, your life, your family, your faith...EVERYTHING. Your autobiography needs to be 3-5 minutes, no longer.  
**Step 4:** Create a DVD of some of your previous video work and the autobiography video from Step 3. Make 2 copies of the DVD and label the outside with your full name.  
**Step 5:** Collect 3 individual letters of recommendation. These need to come from someone outside your immediate family. (i.e. Youth minister, priest, deacon, teacher, employer, etc.) At least one needs to be a professional reference or from a teacher.  
**Step 6:** Mail the resume, application, background check, 2 copies of your DVD, and the three letters of recommendation to:

An email will be sent to you stating that we have received your entire application. (If you do not receive an email within 2 weeks of mailing your application, give us a call.) You will then be contacted and interviewed over the phone. After the phone interview, we will contact you with our final decision.

Upon acceptance Life Teen will provide travel arrangements to and from the nearest airport location of the camp that you will serve. Your commitment will be from the first date listed on your session to the last date. You will remain with the camp team for the entire session. You will receive technical assistance from the media team but will be responsible to the camp coordinator for community prayer involvement. On the weekend you may participate in activities outside of camp, so any spending money will be at your discretion. Life Teen will provide meals, housing, linens, and transportation with the session time.
